Important Information & Conditions of Entry

1. You must provide an EFA or SEG membership number or your entry will not be accepted.
2. This event will be conducted under EFA rules and the requirements of the QLD DPI&F
3. All competitors please note that swabbing may occur at this event.
4. No refunds after close of entries without a Vet or Medical Certificate.
5. Riders must be SEG or Equestrian Federation of Australia (EFA) members.
6. If the event is cancelled the club may retain \$2.00 per ride
7. Neat and Tidy attire- Tucked in Polo shirt acceptable at members days.
8. Jackets, ties/stocks required at Associate and Official days.
9. Limit of 25 riders per class (reserve list may be established)
10. **Associate and Official days:** Maximum of 3 horses per rider; maximum of 3 tests per horse over 2 consecutive levels
11. **Members Days:** Maximum of 2 horses per rider; maximum of 2 tests per rider over two consecutive levels.
12. **Restricted classes** are for competitors whose horses **DO NOT** have EFA registration and bridle number /performance card
13. **Junior** competitors are those turning 18 in 2010 and younger.
14. Competitors wishing to have test sheets posted please provide your own stamped, self addressed envelope and leave at gear check.
15. **No Dogs** allowed on the grounds.
